You and at least one parent must complete and sign this worksheet, attach any required documents and submit everything to the Financial Aid Office. We reserve the right to ask you for additional information. If you have any questions about verification, contact the Financial Aid Office as soon as possible so that your financial aid will not be delayed.
